- IV. Guest Speaker "Conversations about Dementia" with Brigitta Giulianelli, Capital Region West Program Manager, Alzheimer's Association of NENY:

B. Giulianelli provided the Councils with an excellent, helpful hints program designed to guide family members and providers in having conversations about dementia. Tips focused on breaking the ice to reduce stress and begin uncomfortable discussions about going to the doctor, deciding when to stop driving, and making legal and financial plans. The artful use of "therapeutic fibbing" or "fiblets" was discussed as another tool that can help caregivers respond more readily to repetitive questions or behaviors that can trigger anxiety, power struggles, and distress.

The Alzheimer's Association provides support through their 24-hour Helpline (1.800.272.3900) which is always staffed, and their website (www.Alz.org) which has material on research, training, free programs, community events, supports, merchandise, on-line chat groups, and the Alzheimer's Navigator service to help you find caregiving resources by location across the nation.
